Paul made a motion to have Ruben's company do some landscaping work at the Lift Station and the two Bioxide Stations for approximately \$3287.

Paul went over with the Board a list of financial institutions that are approved by the State Board of Accounts to find better rates. TCU is one that we will pursue.

Linda handed in her March 2023 time sheet to be signed.

The financials for Key Bank and 1st Source Bank were handed out. Noting that she transferred \$10,000 from Key Bank Checking to the Money Market.

- 1. There were no Alarm or Alert calls this month from Omni-Site.
- 2. There were no problems this month at the lift station. The average pumping rate for both pumps this month was 166.8 GPM.
- 3. There were 41645 readings recorded on the H2S data logger this month, the average for the month was 0.099PPM, the minimum was 0 PPM, and the maximum was 7.0 PPM.
- 4. The Bioxide stations were functioning properly this month. The pumping rate for the North station was an average 6.6 GPD for the month, the pumping rate was increased on the 20th, and the South station averaged 5.5 GPD. The tank levels on April 29th were approximately 140 gallons at the South (CR109) station and 250 gallons at the North (Northshore) station.
